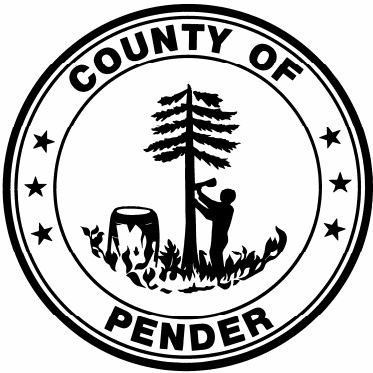




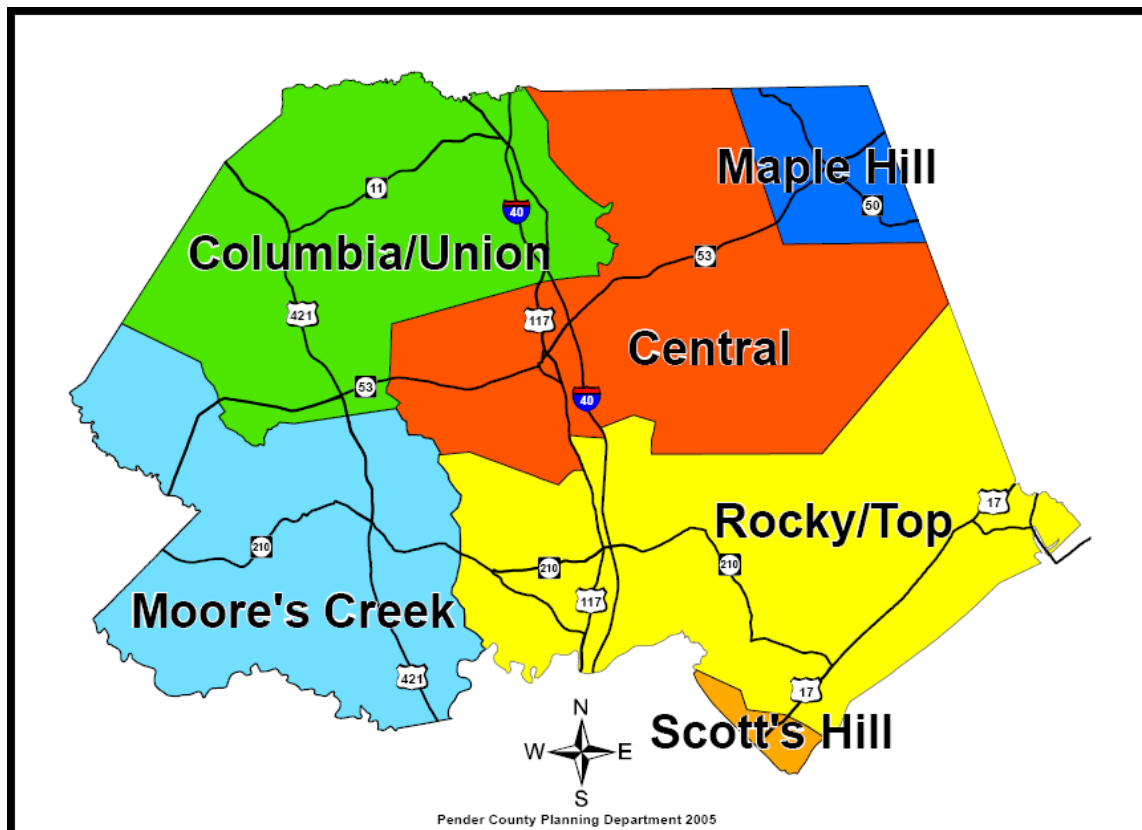

NOTICE OF PUBLIC HEARING ON PROPOSED FORMATION OF SCOTTS HILL, CENTRAL PENDER, MOORE'S CREEK, COLUMBIA/UNION, AND MAPLE HILL WATER & SEWER DISTRICTS

The Board of Commissioners of Pender County, North Carolina will hold public hearings on Monday, February 20, 2006 beginning at 7:00 p.m. or soon thereafter in the Public Meeting Room, 805 South Walker Street, Burgaw, NC 28425.

The purpose of the public hearings is to receive public comment concerning proposals for the County to create "Scotts Hill", "Central Pender", "Moore's Creek", and "Columbia/Union" Water and Sewer Districts. The Maple Hill Water District is proposed to become a Water and Sewer District. The reason for creating these districts is to provide an organizational structure for applying for State and Federal grants and loans in order to fund the design and construction of water and wastewater facilities. CENTRAL PENDER WATER & SEWER DISTRICT

DESCRIPTION

Located in portions of Holly Township and all of the Burgaw Township (part of Rocky Point Precinct, Long Creek Precinct and all of North and South Burgaw Precincts and all of Upper and Middle Holly Precincts). Bounded by the Duplin County line from the Northeast Cape Fear River east to a point 2 miles west of NC Hwy 50. Then south-southeast to Angola Creek. Due east to the Onslow County line, crossing Godwin Rd and Williams Rd. Three (3) miles southeast along the Pender/Onslow County line, then eight (8) miles southwest along the Holly Township and Topsail Township Boundary. Due west to the Northeast Cape Fear River, crossing Shaw Hwy. North along the Holly Township and Burgaw Township boundary to Jamaica Dr. West-northwest to a point north of Far Side Dr. then west-southwest to I-40. South following I-40 to a point north of New Rd then west to US 117 between New Rd and Over St. South along US 117 to Milam Ct. Southwest to a point north of Ashton Rd. West-northwest to Stone House Rd. Along Stone House Rd to Fennel Town Rd. Along Fennel Town Rd to Herrings Chapel Rd. Along Herring Chapel Rd to the Burgaw Township and Long Creek Township Boundary. North following the Burgaw Township and Long Creek Township Boundary then following the Burgaw Township and Columbia Township Boundary. East following the Burgaw Township and Union Township Boundary to the Northeast Cape Fear River. North following the Northeast Cape Fear River to the Duplin County line. The "District" **excludes** the incorporated town limits of Burgaw and its' extra territorial jurisdiction (ETJ) and the Village of St. Helena and its' ETJ.
