

ELECTION RECAP

Pender County completed a successful Municipal Election November 4th, 2025. We had 987 voters cast ballots during the early voting period, and 786 voters vote on Election Day. Including provisional and absentee ballots, 1,811 ballots were cast this election. We want to thank all those who came out and cast their vote.
