Voting Instructions

- a. Examine the ballot carefully.
- b. Once you have made your selections, press the GRAY button next to the candidate of your choice. An X will appear next to that candidate.
- c. If you would like to change your selection, press the GRAY button and make a different selection.
- d. Once you have completed your selections, press the RED CAST VOTE button to cast your vote.

DO NOT PRESS THE RED CAST VOTE
BUTTON UNTIL YOU HAVE MADE ALL OF
YOUR SELECTIONS.

Straight Party Ticket

- a. To vote for all candidates on one party (a straight party ticket), press the GRAY button next to the party of your choice.
- b. You may vote a split ticket by not pressing the GRAY button next to the party name, but by pressing the GRAY button next to the name of each candidate of your choice.
- c. You may also vote a split ticket by pressing the GRAY button next to the party of your choice, and then pressing the GRAY button beside the name of any candidate you choose of a different party.
