Still high on the list of priorities for the next 5 years is the creation of senior/disable housing for our community. Currently there is still no such designated housing in Pender County. The success of this accomplishment is to solicit private investors interested in creating low income housing for senior/disabled and possibly apply for funding.</p>

Continue to solicit for new landlords and educate them on the Housing choice voucher program.</li> <li>4. Collaborate with nonprofit agencies or private investors to bring affordable housing opportunities to Pender County residents.</li> <li>5. Maintain and improve SEMAP score</li> </ol>
B.3	<p><b>Progress Report.</b> Include a report on the progress the PHA has made in meeting the goals and objectives described in the previous 5-Year Plan.</p> <p>No progress has been made on previous 5-year plan. As hurricane Florence depleted a lot of our housing stock. Although the population and the need has grown for Pender County the funds limit what we as a housing authority can accomplish. The rents have gone up since 2019 but the FMR has gone down making it hard for our voucher holders to find adequate housing.</p>
