7. Current Situation: EOC IS OPERATING AT A LEVEL 3 STATUS. Level 3 is a hazard specific response to an incident. This incident requires the assistance of several State agencies. The Emergency Operations Center is activated but only staffed with essential personnel. The EOC is not operating on 24-hour shifts. The EOC is only functioning during standard business hours, with minimal weekend staffing.

Weather: Today: Partly sunny, with a high near 58. North wind around 13 mph, with gusts as high as 21 mph. Tonight: Mostly clear, with a low around 43. North wind 5 to 8 mph becoming calm in the evening. Tomorrow: Sunny, with a high near 66. Northwest wind 6 to 9 mph, with gusts as high as 18 mph. No hazardous weather is expected at this time.

Fire Weather: RP-1: Clearing skies as high pressure settles into the region with relative humidities as low as the mid 30s through Friday. Gusty NNW winds today will ease late in the day. Seasonably cool and dry weather can be expected through the weekend. The next chance for rain expected early to middle of next week. Wind profile analysis/fire control over flat terrain is Favorable. Fog potential for tonight is Low.

GOVERNOR COOPER EXECUTIVE ORDERS (EOs)

- EOs 117, 118, 119, and 120 remain in effect except as superseded by subsequent orders. Details here.
- EO 121 (March 27, 2020): Issued "stay-at-home" order to take effect at 5:00 PM Monday, March 30, 2020 for a period no less than thirty (30) days, established essential activities and essential businesses, reduced the mass gathering limit to 10 persons, and clarified local authority to establish greater restrictions in accordance with North Carolina law.
- EO 122 (March 30, 2020): Helped schools and local governments access state surplus property to help bridge gaps, provided transfer or donation of personal protective equipment (PPE) that state government may have and not need.
- EO 124 (March 31, 2020): Prohibited utility shut-offs, late fees, and reconnection fees; provided guidance about restrictions on evictions; encouraged telecommunications providers, banks, and mortgage servicers to provide assistance and flexibility to their customers.
