



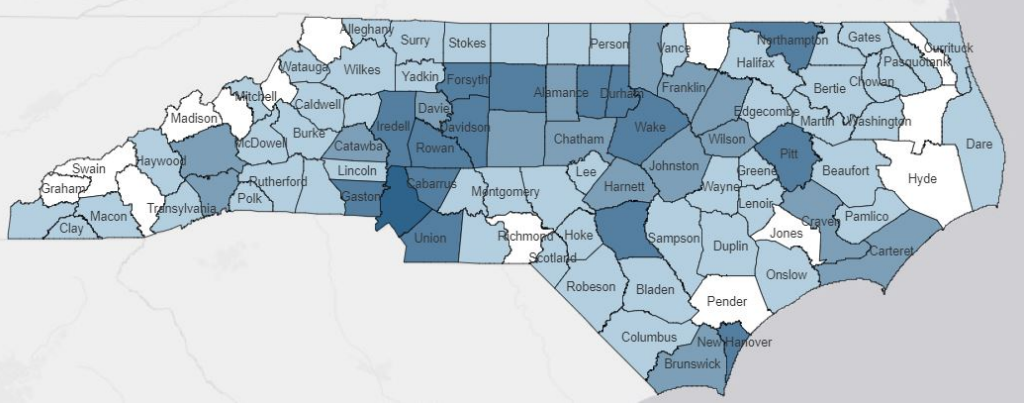
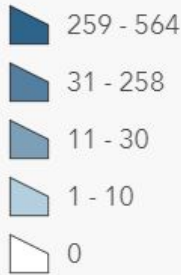
**Pender County Situation Report #23 - COVID-19 Event

| <p>7. Current Situation: EOC IS OPERATING AT A LEVEL 3 STATUS. Level 3 is a hazard specific response to an incident. This incident requires the assistance of several State agencies. The Emergency Operations Center is activated but only staffed with essential personnel. The EOC is not operating on 24-hour shifts. The EOC is only functioning during standard business hours, with minimal weekend staffing.</p> <p>Weather: Today: Sunny, with a high near 72. Northwest wind around 13 mph, with gusts as high as 21 mph. Tonight: Clear, with a low around 46. West wind 6 to 8 mph. Tomorrow: Sunny, with a high near 69. North wind around 8 mph. Elevated fire danger today, No hazardous weather is expected Saturday through Thursday at this time.</p> <p>Fire Weather: RP-4: Low pressure off New England and high pressure west of the area, will combine to keep breezy NW winds across the region today, coupled with low RH, leads to an elevated fire danger primarily with fine fuels. Winds will ease into the weekend as high pressure draws closer, and today appears to be the driest day. Rain chances return early to middle of next week, combined with a warming trend. Wind profile analysis/fire control over flat terrain is Favorable. Fog potential for tonight is None.</p> <p>GOVERNOR COOPER EXECUTIVE ORDERS (EOs)</p> <ul style="list-style-type: none"> EOs 117, 118, 119, and 120 remain in effect except as superseded by subsequent orders. Details here. EO 121 (March 27, 2020): Issued “stay-at-home” order to take effect at 5:00 PM Monday, March 30, 2020 for a period no less than thirty (30) days, established essential activities and essential businesses, reduced the mass gathering limit to 10 persons, and clarified local authority to establish greater restrictions in accordance with North Carolina law. EO 122 (March 30, 2020): Helped schools and local governments access state surplus property to help bridge gaps, provided transfer or donation of personal protective equipment (PPE) that state government may have and not need. EO 124 (March 31, 2020): Prohibited utility shut-offs, late fees, and reconnection fees; provided guidance about restrictions on evictions; encouraged telecommunications providers, banks, and mortgage servicers to provide assistance and flexibility to their customers. EO 125 (April 1, 2020): Authorized and encouraged remote shareholder meetings during the State of Emergency. <p>The public can subscribe to text updates from NC DHHS regarding COVID-19 by texting COVIDNC to 898211. Incident Area: As of today (4/3), the Pender County Health Department is aware of a total of **seventy-one (71) residents of Pender County** who have been tested for COVID-19 by healthcare providers within the county. Of those tests, **sixty-two (62)** were confirmed negative, while **nine (9)** tests are currently pending. There have been no confirmed positive tests.

12. External Affairs: Pender County remains in monitoring mode. The Public Information Officer and the communications team are monitoring the County’s social media platforms and updating the County’s website with accurate information.

13. County Action:

- Pender County School System is feeding students and anyone 18 or younger at 61 sites, information [available here](#).
- Pender County Schools is providing wi-fi hotspots for school-issued devices from 7 AM to 7 PM seven days a week at Pender High, Topsail High, Heide Trask High, and West Pender Middle. There is also a public wi-fi access point in the parking lot of the Pender County Public Library in Burgaw.
- Pender County Government is strongly encouraging appointments for in-person visits, information [available here](#). In accordance with the governor’s order that teleworking be practiced to the maximum extent possible, many staff members began teleworking starting Tuesday, March 31.
- Pender County Board of Commissioners Chairman George Brown declared a State of Emergency effective Monday, March 30, 2020.

14. Other Notes, Issues or Additional Remarks: Pursuant to EO 117 issued March 14, 2020, all persons are urged to maintain social distancing (approximately six feet away from other people) whenever possible and to continue to wash hands, utilize hand sanitizer and practice proper respiratory etiquette (including coughing into elbow).
