QUESTIONS and ANSWERS

- Q1: Are you looking for pricing just based on 10 GBPS or should the pricing include other speed options like 1 GBPS, 2GBPS, and 5 GBPS?
- A1: The Hub location(s) will be the point of entry for remote buildings to interconnect to the County's network.

 To accommodate existing and future needs, the bandwidth needs to be scalable to 10Gbps. Bidding vendors are welcome to supply speed options as long as pricing for the requested 10GBPS is included.
- Q2: Is Pender County also interested in having the vendor supply a managed router for each location?
- **A2:** Vendors may provide costs for both managed router and customer provided router if available.
