### COOPERATIVE EXTENSION

**4-H Youth Development - Traci Spencer**— completing summer day camps. Sent two 4-H youth to the Eastern Center 4-H Camp in Columbia, NC. Five others will be going to Betsy Jeff-Penn 4-H Camp next week in northwest NC. Traci will be spending a week at Mill Stone 4-H camp in early August assisting with 4-H camp at that facility. Finished virtual 4-H Congress. Two Pender County 4-H teens have earned state level leadership positions. Working to hire a part time 4-H program assistant and a part time Empowering Youth and Families program assistant for Pender County.

**Consumer Horticulture - Tiffanee Boone** – Pender County Extension Master Gardener volunteers are planning for the 2021 Speakers Bureau programs. They are also starting back up with the Horticulture in the Classroom program for Pender County elementary students. Research is being conducted on disease resistant basil varieties. A variety highly susceptible to mildew is being planted with five new varieties that are supposed to be resistant to the mildew in sites all over NC. Pender County is one of the test locations for this research. Attended three days of video training with NCSU Videography professionals to improve the content and quality of the education videos we will be working on in the coming months.

**Area Natural Resources and Environmental Education Agent - Amy Mead** - completed three days of video content training with NCSU videography professionals. Working with homeowners associations in Pender, New Hanover and Brunswick County to improve storm water retention structures. Assisting homeowners with aquatic weed management.

**Agriculture and Commercial Horticulture / Administration - Mark Seitz, County Extension Director** - attended 3 days of video content training with NCSU videography professionals to improve video education content coming out of the Extension office(s). Provided soil fumigation education for licensed soil fumigant applicators across NC via Zoom. Finalizing the 2020-21 County Trade Pull Factor Report and presentation for the upcoming Aug 9 BOCC meeting. Met with the Extension Advisory Board to discuss future programs. Conducting interviews for two part time Extension positions.

Multiple media interviews and press releases completed with the preparing and the threat of tropical weather systems as hurricane season starts up. Many of the annual overdue inspections completed this month. The department has selected in a new Fire Marshal which will start in July.

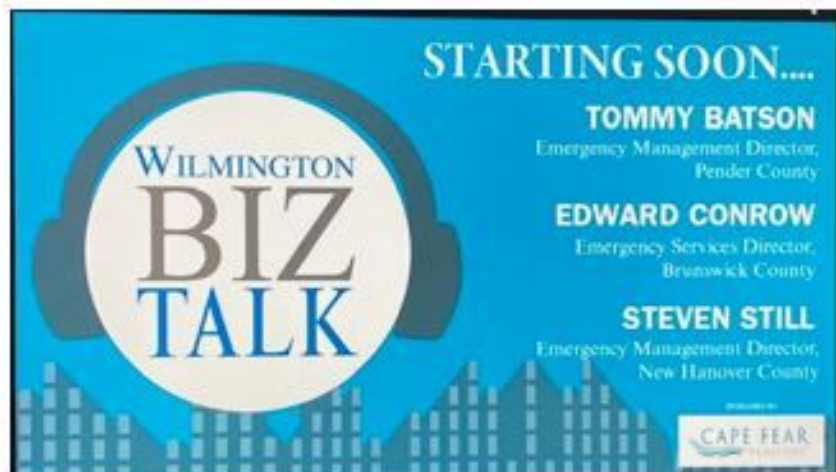

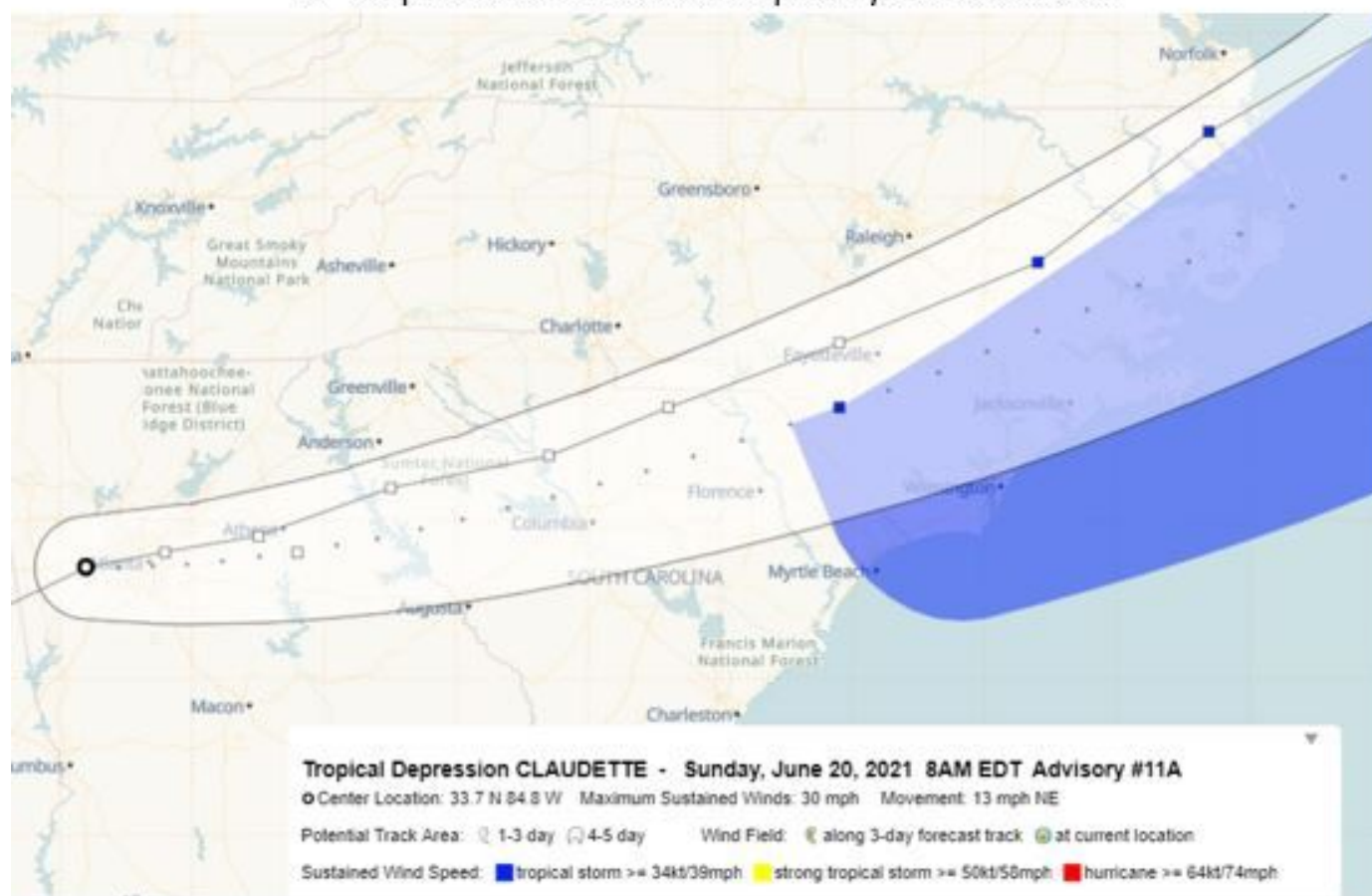
- Running Deer Trail Fire-Staff has continued to monitor this fire for a total of 134 days since it was first reported on Feb 15, 2021.

### HEALTH - GENERAL

There has been an increase in COVID-19 in the county. The health department is receiving 10-11 new cases per day compared to 2-3 cases per day a couple of weeks ago. The increase has been related to the Fourth of July holiday, church activities and youth group trips.

Those not vaccinated should wear a mask.

Vaccinations are available five days a week in Burgaw and at the Hampstead Annex. There is Moderna vaccine as well as Pfizer vaccine for those 12-17 years of age. No appointment is needed.

Fifty percent of Pender residents 18 years of age and older have received at least one dose of the vaccine.

Health educators participated in a job fair at Cape Fear Community College for nursing students. In addition, they attended the Disaster Preparedness Expo sponsored by the Long Term Recovery Group. Information was available for the county's Special Needs registry. This registry lists residents with medical or physical conditions that prevent them from evacuation to a public shelter in the case of a disaster. Staff assist them in making plans should such an event happen.

Health education staff will be participating in a Domestic Violence Awareness event this week. Next week staff will be providing blood pressure checks at Moore's Creek Baptist Church.

The mobile dental unit is at Penderlea School.

Met with architects for final discussions on a preliminary design for an HHS facility.

A new WIC Director and an environmental health specialist will begin work next week.

Continue to recruit for public health nurses as there are currently three positions vacant.

### LIBRARY

As of July 22, Pender County children have logged 2,710 hours of reading as part of our summer reading program! Children get a prize (a toy and a book) for every ten hours of reading that they report. Our reading incentive program helps avoid the “summer slump” while children are off for summer break and encourages children of all ages to read more!

Our Early Literacy Outreach program provides licensed childcare facilities throughout the county with bags of books each month. The childcare facilities can request books by theme to align with their curricula. In June, we provided 480 books to 43 classrooms throughout the county!

The Hampstead Branch Library has a take-home activity we’re calling Shell a Tale and Rock your Story. We have on display a table full of seashells and rocks. Each seashell or rock has a writing prompt written on the bottom. Children can take a shell or rock and write a story or poem inspired by the prompt. If they like, bring what they wrote back to the library to be put on display.

On July 16,2021 social workers, social work supervisors and social work program manager participated in a provider( Pinnacle Family Services) presentation specific to Family Centered Treatment(FCT). FCT is an evidence based family preservation model of home-based treatment owned by a private non-profit incorporated organization devoted to the presentation of families through research, training, and development. Through four phases of (FCT) 1. Joining, 2. Restructuring, 3. Value Change, 4. and generalization, highly successful engagement rates are obtained by families. This service is only for Medicaid recipients and can be utilized by 210, 215 and 109 social workers.

NC DHHS DSS Child Welfare Consult is scheduled on July 29,2021. Division Regional Child Welfare Consultant, Daphine Little will be on-site for the first time in over a year. Our agency is excited to resume a successful partnership with our Division partners.

#### Tourism Update

Pender County Tourism is moving forward with **Ghost Walk: Ghosts of Pender's Past**. Tourism approached the Town of Burgaw Board and formally asked permission to move the Ghost Walk from Downtown Burgaw to the Burgaw Cemetery. The Board approved the decision with the condition that there be a resolution proposed at the next Town meeting to temporarily alter the Cemetery hours listed in the ordinances. The official announcement will be released after the August Town of Burgaw meeting.

The tourism office met with Peter Sloan, the organizer of **Jeep Week**. He has an event model that disperses Jeep Week attendees around the area to explore our attractions. The event will take place in September.

We returned to the community of **Edgecombe** for an interview with Maryland and Air Force veteran Curtis Hardison. He is writing a book about Edgecombe. Meanwhile, Pender County Library Staff, led by Allan Phillips-Bell, scanned many historical documents.

Tammy attended the UNC School of Government class on **Crisis Communications**.

We continue to work with the Friends of the **Mountains to Sea Trail's** land acquisition committee.

The board of directors of the **Friends of the MST** meets in person, for the first time since COVID, on Friday.

We met with Dr. Richard Newkirk and filmmaker Claudia Stack, and Tammie Parris of Cape Fear Community College to bring together histories and interviews surrounding **CF Pope**.

The tourism team is serving on the county employee Tailgate **planning committee**.

Tourism is assisting with the **Aug. 6 Courthouse Open House and Dedication**.

We celebrated ribbon cuttings and provided photos and posting announcing the opening of a new business, **Top Sea Wingz**, and the new satellite office of **Communities in Schools**. Both Facebook posts attracted terrific comments.

We are serving on the **North Carolina Beach Inlet & Waterways events committee** to plan the Nov. 4-5 conference.

We have helped orchestrate a book signing with Ray McAllister and his daughter, Lindsay. Ray has released an updated second edition of his acclaimed book **Topsail Island: Mayberry by the Sea**. Lindsay, a high school teacher, has authored three children's books centered on Topsail. The event was at Missiles and More Museum and it was well attended.

We continue to **support and collaborate** with both chambers of commerce.

We are preparing for the return of the **NC Blueberry Festival** to the office space.

We continue to work with **North Carolina Coast Host**.

Olivia assisted volunteers at **Canetuck Rosenwald School**. The school is open every Thursday in July for tours.

### UTILITY OPERATIONS

#### PENDER COUNTY UTILITIES (PCU) & WATER DISTRICTS:

We have scheduled interviews next week for the new Utilities Inspector position and plan to advertise for the new Project Manager and Solid Waste Maintenance Technician next week.

Design is proceeding for the Scott's Hill WSD Elevated Water Tank & Wells project, with construction bidding advertisement anticipated for early December. Current scheduled project completion is April 2023.

The Rocky Point-Topsail WSD RO Water Plant & Associated Improvements project is on-hold pending site procurement.

#### Field staff work and status updates since last report:

- Automatic flush valve on daily flush on Camden Court and Michigan Avenue.
- 3 Taps by staff, 2 moved services, and 2 meter relocations.
- 281 locate requests in the last two weeks.
- Power outage at Del Labs Pump Station. Power company replaced transformer on pole.
- Installed hydrant meter at Blake Farms "The Reserve" in Scotts Hill.
- Rigorous flushing in distribution system in Wyndwater and surrounding areas due to numerous colored water complaints. This had a much-improved result and dealing with two customers on complaints.

## WATER TREATMENT PLANT

The after-effects of TS Elsa are showing up in the raw water quality coming into the plant. Jar testing (pictured) and increasing the coagulant dose kept the plant running smoothly with no issues.

One of the two new recycle pumps ordered for the pond discharge arrived. These pumps are manufactured in Sweden and have a lead time of 6 weeks. Staff will be installing this pump in the next week or so.

Lightning took out some equipment around the plant. Repairs were made.

Put together shelving in the garage to begin moving equipment out of the BASF building.

Updated SCADA alarms to include critical call outs and on-site notifications.

All Monthly State reports for June have been completed and submitted.

IT was in site to install two new wireless access points.

Water production numbers for July through the 21st: 32.4 million gallons for an average of 1.54 MGD

## PCP WASTEWATER TREATMENT PLANT - MKKAES (Melinda K. Knoezer Adaptive Ecosystem)

## SOLID WASTE

The Transfer Station scale house is operating well. We have two full time employees and are currently in the process of interviewing for a part time employee.

There will be upgrades to the scale house beginning soon. These will include new flooring, two desks and a larger refrigerator.

Transfer Station daily creates about 99 - 110 disposal tickets daily. Waiting time at scales is about 3 minutes in and 4 minutes out.

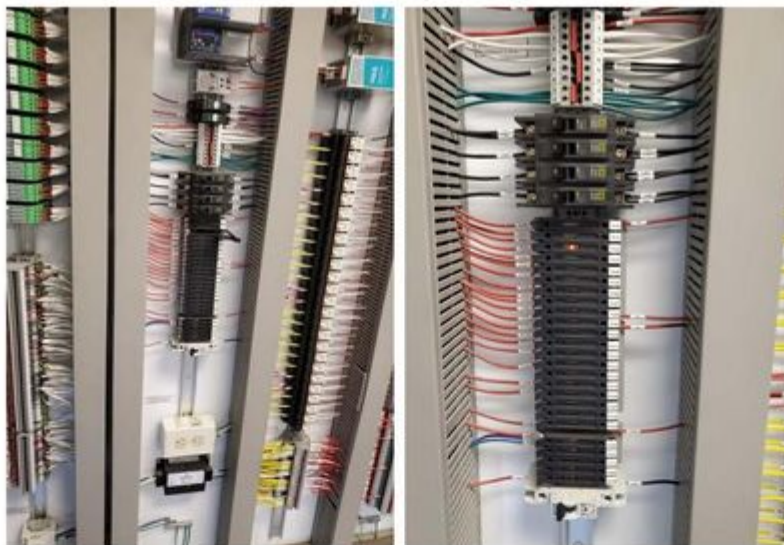
