The Bid Schedule in the RFP listed DSR-047 as requiring 300 tons of Class I rip-rap. The correct scope of work is 100 tons of Class II rip-rap. Attached Bid Schedule for Task 2 shows corrected amounts.
- **2.** Task 2-Scope of Work: Streambank Stabilization Bid Schedule Addendum 3, Scope of Work, lists DSR-049 as requiring 180 total tons of Class I rip-rap. The Bid Schedule in the RFP listed DSR-049 as requiring 176 tons of Class I rip-rap. The correct scope of work is 180 tons of Class I rip-rap. Attached Bid Schedule for Task 2 shows corrected amounts.
