Bi-Weekly Programming Update – Oct 29, 2021

NC Cooperative Extension Agents work with Pender County residents and farmers, helping them find research-based solutions to problems. We work in agriculture, horticulture, natural resources and the environment (storm water, erosion, wetlands restoration, water quality, etc.) and 4-H Youth Development teaching civic leadership and community development.

Consumer Horticulture – Tiffanee Boone

Pender County Extension Master Gardener volunteers (EMGV) released the 2021 Speakers Bureau program. The schedule is available at: <https://pender.ces.ncsu.edu/2021/08/pender-county-extension-master-gardeners-speakers-bureau-update/>. The next one will be done in person and through zoom at the Hampstead library. Pender EMGV will resume their Horticulture in the Classroom program for Pender County elementary students through zoom. Pender EMGV are hosting a youth activity and plant sale at Poplar Grove's Halloween Festival Goosebumps in the Grove on October 30th from 10-5 pm and October 31st from 10-4 pm. They will be selling trees such as Scarlet Oak, Persimmon, and Redbud as well as an array of houseplants and outdoor perennials. Pender EMGV received several applications for horticultural grants and will make final decisions on them in December. Grant money will be awarded in January. Research continues on disease resistant basil varieties and results will be coming out in the next couple of months. A new initial Master Gardener class is planned for January. Area Environment and Natural Resources Agent – Amy Mead

- The Agent taught a statewide class entitled 'Coastal Ecology of North Carolina: From the River to the Sea' for the NC Cooperative Extension Backyard Naturalist program. The two-hour program taught students about unique and important coastal habitats, the geological history of the coast and the current threats faced by coastal communities due to sea level rise.
- The Agent taught 'Native Trees for Resiliency' for the Southeast Chapter of the NC Native Plant

Society. Attendees learned about the importance of urban tree canopy cover for water quality and wildlife as well as the most hurricane resilient native tree species that are appropriate for landscapes.

Administration – Mark Seitz & All Extension Staff

- All Agents and Extension staff participated in three days of our Annual NCSU Extension Conference. It was held virtually, and all staff participated in 10 professional improvement training sessions over three days on a variety of topics.
- All Agents and staff attended the Hugh Shelton Leadership Conference (virtually) hosted by NCSU. Hugh Shelton is an NCSU graduate and former Chairman of the Joint Chiefs of Staff for the US Military.
- Completed interviews for the Pender County Expanded Foods and Nutrition Program Assistant position. A candidate has been selected and an offer of employment is pending. This position is funded by NCSU and will deliver food and nutrition education to elementary age youth from limited resource families throughout Pender County.

Agriculture / Commercial Horticulture – Mark Seitz

- Dry conditions continue across the county. Soybean yields are running close to average (35 bushels per acre) but vary significantly based on planting date and maturity.
- Fertilizer and chemical prices have nearly doubled since January 2021 and farmers are struggling to make crop decisions for 2022.
- Assisted the Topsail High School Horticulture Teacher and students with planting strawberries as an education/demonstration project.
- Strawberry planting is complete across the county, but irrigation pond levels are lower than normal. This could create challenges for strawberry and blueberry farms that rely on irrigation water for frost protection next spring if water levels in irrigation ponds are low.
- Some winter wheat is getting planted but soil conditions are dry and farmers are waiting for rainfall to get better seed germination.

PLANNING

Permitting and Permit Data: Pender County's Permitting Division continues its excellent work recovering from significant challenges faced during the spring of 2021. Using single-family residential building permits as an indicator of success, the average turnaround time for this type of permit since August 1, 2021 of this year still just over 13 business days. 135 permits of this type have been applied for during this time period, eighteen of which were applied for since the last County update. The average turnaround time is expected to continue to tick slightly upwards as time goes on due to permits being put on hold for various reasons. While the average turnaround time is below the County's target of a fifteen day turnaround for all permits, the Permitting Division is committed to bringing this turnaround time figure down further.

In terms of single-family permits issued, the County has seen a decline in the number of permits issued per month over the last four months. The month of June saw 112 single-family residential permits issued, July saw 88, August saw 61, and September saw 47 of that particular permit type issued. So far in October, as of noon on October 29th, 38 of these permits have been issued. A desktop analysis as to the reasons behind this decline found that there are a number of large scale subdivision projects that are reaching the end of their lot inventory. That being said, a number of those projects have additional phases coming forward, and there are new subdivision projects that will be coming forward for platting in the not-too-distant future as well.

Building Inspections: A big congratulations to Greg Lawrence, Building Inspector for passing his Plumbing Level 1 standard certification test. Greg is a great inspector and the whole County is very proud of him. The inspectors are now 5 for 5 on passing new certification tests so far in 2021, which is no small feat.

Long Range Planning: Pender County Planning has working to assist the Parks and Recreation Department in an update to the Pender County Parks and Recreation Master Plan. The Board of County Commissioners approved a contract with McGill Associates on September 17th, 2021 and since that time, Staff in Parks and Rec as well as Planning have working to get the project underway, with multiple stakeholder meetings and focus groups having been conducted over recent weeks. The steering committee for the project will be meeting in the coming weeks, and the drafting of the first chapters of the new plan will commence shortly.

Meanwhile, the Pender County Board of Commissioners unanimously adopted the update to the Pender County Collector Street Plan on October 18th, 2021. This update is the result of collaboration between the County and the Wilmington Metropolitan Planning Organization, with WSP serving as a consultant, and we cannot thank them enough for their assistance in getting this project to completion. The Plan is now moving on to be considered by the WMPO's Board (of which Commissioner David Piepmeyer is Chairman) on November 17th, 2021, where the consultant, WMPO staff, and County staff will be present. At the same time, we are working with the WMPO to identify additional areas where we can collaborate to further solidify Pender County's long term vision for transportation. The most immediately project we're looking to work on is a Bicycle and Pedestrian Plan for the WMPO's portion of the County. More details to come as they are available!

Current Planning: Pender County Planning staff continue to work on a number of cases, including residential, commercial, and industrial projects. Staff are particularly excited to be currently working on a number of commercial and industrial projects that will seek to bring many exciting new opportunities

to Pender County in terms of providing needed goods and services, as well as employment opportunities, to County residents.

The Board of Commissioners will be holding public hearings on three projects at their November 15th, 2021 meeting in Burgaw. The Pender County Planning Board currently has two cases slated for its November 2nd docket, while the Pender County Board of Adjustment has three cases slated for its November 17th docket. Appropriate public notice has been or will be provided for each of these cases in accordance with state statute and local ordinance. If you are interested in any project the Department is currently working on, please give us a call at (910) 259-1202.

Additionally, the Department wants to again communicate how excited we are to welcome Stephanie Jagoda as our new Administrative Specialist, replacing Tera Cline who has moved to the Clerk position. Stephanie has accomplished quite a bit already and we're very thankful to have her on our team!

Floodplain Management and Resiliency: Emmons Garner has taken over as the County's first Watershed and Drainage Technician. He and Daniel Adams (Floodplain Administrator) are working diligently to ensure that the County is ready to implement the Beaver Bounty program as well as assist citizens with beaver issues throughout the County. As the County continues to oversee stream restoration work under the Emergency Watershed Protection grant program, Emmons has successfully trapped beavers already on nearby sites, working to further increase the effectiveness of the work completed under the grant program. More information will be published on these programs in the very near future.

Emmons and Daniel have also been working directly with other trappers in the County to ensure efforts are being coordinated effectively and efficiently and will continue to do so as we moving into trapping season, which opens November 1st.

UTILITY OPERATIONS

PENDER COUNTY UTILITIES (PCU) & WATER DISTRICTS:

Deputy Director Anthony Colón's last day with PCU will be November 12th. We are currently recruiting for his replacement, as well as an open WWTP Operator position. We also plan to begin recruiting for our new Solid Waste Maintenance Technician position in November. We recently filled our new Project Manager position and 2 open Water/Sewer Maintenance Technician positions.

PCU field staff did an outstanding job performing a water line repair on October 21st. They completed the replacement of 11 feet of 10-inch PVC pipe following damage from the installation of an anchor for a new light pole. All repair work was completed by PCU field staff, with no outside assistance. This is very significant considering how far we have come in the last 2 years in being able to perform work in-house. Our new light boom trailer was a tremendous help as most of the work occurred after sundown. SEE PHOTOS.

The lobby and utility clerks' area remodeling project is now complete. The glass protective barrier was installed on Monday. We have much more space for our staff to do their work now, and a much more attractive area for our customers. SEE PHOTOS.

Field staff work and status updates since last report:

- Automatic flush valve on Camden Court removed temporarily for lot sodding and ditch work. Staff is doing weekly flushing from hydrant.
- Automatic flush valve on daily flush on Riverland Drive and Michigan Avenue.
- We have been receiving red and yellow water complaints in Wyndwater, Watts Landing, & Pelican Reef. Staff is performing end point flushing as needed. We are investigating the use of a different treatment chemical that may address these issues that are resulting from the blending of water from our new wells and water from the treatment plant.
- 2 taps performed in last two weeks by staff. Staff also moved two water services.
- Pressure test completed at the end of Crowne Pointe for new line extension/new home construction.
- Leak repair and "pressure advisory" water line repair on 10/21/21 was due to contractor installing power pole anchor into water line. The water line curved in the vicinity, and they had hand dug two other holes in a line and thought the water line was straight and not curved. The locate marks and

flags were destroyed when DOT cut grass in the highway right-of-way.

- 304 locates in the last two weeks.
- Chris E. and Glen completed wastewater collection certifications classes and will test in December.
- All monthly reports last month completed and submitted.

WATER TREATMENT PLANT

- Repaired drain valve on filter #1.
- IT Department was on site to replace switches and install UPS at the plant.
- Staff completed training on Colilert 18 sampling procedures.

- After some raw water quality issues earlier in the month everything seems to have settled back to normal. Overall, the plant is running really well with no issues.
- Water production numbers for October through the 27th: 36.5 million gallons for an average of 1.35MGD

PCP WASTEWATER TREATMENT PLANT - MKKAES (Melinda K. Knoezer Adaptive Ecosystem)

The numbers at the plant continue to look great; however, the plant has seen many challenges in the past two weeks.

- We pulled a small transfer pump from the digester to find it had water in the windings.
- Our DI (deionized) water filtration system in the lab went down.
- We had a switch in our server go down that has half the plant running in a manual mode.
- We had a disc filter backwash cycle fault out over the weekend which caused us to work Saturday and Sunday.

But we are up for the challenge and so far. The plant process hasn't been affected by any of this. GO TEAM!

The Transfer Station scale house is operating well. Things are a little slower this past week. I have contacted another flooring company to give me a quote so that we can proceed with much needed new flooring in the scale house.

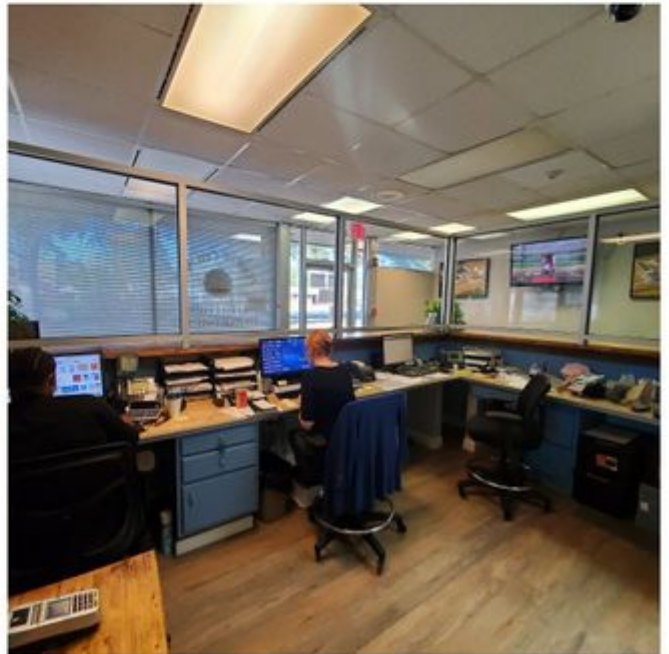
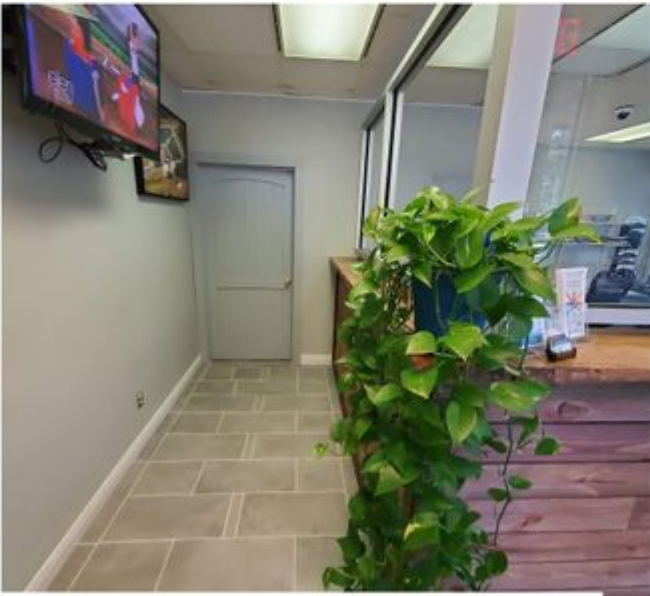
Transfer Station daily creates about 100 - 115 disposal tickets daily. Waiting time at scales is about 3 minutes in and 4 minutes out.
