## **Breaking News from Department of Veterans Affairs**

VA will propose adding **9 rare cancers** to the presumed service-connected list as related to military environmental exposure in addition to the 3 presumptive conditions that were previously listed in May 2021.

Those conditions release in May of 2021 were: asthmas, rhinitis and sinusitis.

The new presumptive conditions listed are cause by FPM exposure (Fine Particulate Matter). Veterans presumed to have been exposed to FPM if they served in:

SW Asia Theater of Operations from 8.2.1990 to present

Afghanistan, Djibouti, Syria, or Uzbekistan from 9.19.2001 to present.

The 9 rare respiratory cancers are listed as the following:

Squamous Cell Carcinoma of the larynx

Squamous cell carcinoma of the trachea

Adenocarcinoma of the trachea

Salivary gland-type tumors of the lung

Large Cell Carcinoma of the lung

Salivary gland-type tumors of the lung

Sarcomatoid carcinoma of the lung

Typical and atypical carcinoid of the lung

If you have a clinical diagnosis for these conditions call your local Veterans Service Office at 910-259-1203 Burgaw or 910-270-5005 Hampstead for appointment to file claim or reopen previously denied claims along with the medical evidence.

## PENDER COUNTY UTILITIES (PCU) & WATER DISTRICTS:

The Scotts Hill Elevated Tank & Wells project is out for bids, with a bid date of May 3rd at 10am at PCU offices. We will also have a virtual pre-bid conference on April 12th at 10am.

We currently have 4 job openings for Water/Sewer Maintenance Technician, Meter Reader, Project Manager-Utilities, and Solid Waste Maintenance Technician. I am hopeful to make an offer for the SWMT within the next week. Interviews for the other positions will be later this month.

The Factory Road Water Extension construction is complete, but the contractor is searching for a small leak right now. Hopefully the pipeline will go online within the next couple of weeks.

Field staff work and status updates since last report:

- · Lots of inspections of new subdivisions have been performed over the last couple of weeks.
- In-house training of newly promoted staff has been ongoing.
- The large dump truck repairs were finally completed, so we are working on hauling rock to the transfer station and other sites as needed.

#### MAPLE HILL WATER SYSTEM & WASTEWATER TREATMENT PLANT

This week we were able to disconnect from the Chinquapin water system, and start receiving all water from ONWASA. The automatic valve has been installed, but we are still awaiting completion of the electrical controls. We are operating the interconnection manually until the electrical connections and setup are completed. At the WWTP, we are coordinating with contractors to mow the ditch and other difficult areas, and are having repairs done to our gear drive chain in the main treatment basin. We are also working on repairs to the plant flow meter.

#### WATER TREATMENT PLANT

Backwashed GAC #3 (GAC backwash flow into pond pictured). Repaired door to the High Service Pump Room. Installed new controller and repaired finished water turbidimeter.

Operator Erin completed B-Surface school.

Raw water quality has not been great, coagulant dose has been 140mg/L for the past two weeks. Staff ran multiple jar tests and ferric dose is back down to the usual 90 mg/L as of March 30th.

Water production numbers for March through the 30th: 39.7 million gallons for an average of 1.32 MGD

PCP WASTEWATER TREATMENT PLANT - MKKAES (Melinda K. Knoezer Adaptive Ecosystem)

Staff has been extremely busy responding to a plant upset over the last month. It is believed that the upset was the result of some outside wastewater flow we recently accepted for treatment, which over time overwhelmed the plant with an unhealthy bacterium.

Our plant is usually very efficient at consuming ammonia. Normally when we see Ammonia numbers start to grow in the clarifier, we would do one extra wasting and the number would drop overnight but this month it has been a very different story. We tried extra wasting when we saw this number start to climb. This time that didn't work. On March 2 we tried bringing some sludge back from the digester to reseed our bugs/bacteria. On March 3 we did see a decrease. We pulled samples extra samples that Friday and Saturday just to monitor, fully expecting we had fixed the problem. At this point all the other plant numbers looked great.

On March 7th everything seemed normal but the next day when we got the testing result it was alarming. We made phone calls to our customers asking if they had changed cleaning products or methods. Our answer from all of them was no. We also noticed that the maggots in our headworks dumpster were all dead. Sampling daily, we thought we would start seeing numbers drop after the second day. Since all the other number looked good, we still thought ammonia weekly average would be good if we kept pulling over the weekend. By Friday we were skeptical so I call DEQ to let them know that we may not meet our weekly average. We missed it by 0.19, but not by a lack of trying. On Monday March 14th I sent them an email letting them know.

On third week we started made a plan to start up our second clarifier, thinking that the ammonia might be coming from algae. Our ammonia was getting converted in the MBBR but coming back up in the clarifier. We started getting ready to wash down the clarifier before putting it online. This pretty much filled our digesters. On Friday we turned the air off to one the digesters so we could decant the next week.

On the March 21st we saw elevated foaming that we spent time knocking back with the hoses, but the clarifier did not look really bad until the next morning. This is when it appeared that the sludge blanket was starting to stratify. At the time we didn't know what was going on. We increased our return rate and continued to spray down the foam. Our disc filters were in a state of almost constant backwash. We started decanting the digester so that we could waste more. By the night of the 27th we were able to start filling the second clarifier. As the clarifier filled, we slowed the plant down and again increased the return. We did not discharge on the 28th and by the 30th we now have a good handle on the foaming. Sludge is settling like it should and all of today's onsite lab numbers are all in range. We will not get BOD numbers back for a couple of weeks. We are working on hauling sludge out of the plant and we will continue to fight back the filamentous bacteria. At this point I believe we are back to normal operation.

#### SOLID WASTE

- The Transfer Station scale house is operating well.
- The ladies are taking precautions and staying healthy.
- Waiting time at scales is still about 3 minutes in and 4 minutes out.
- Traffic through the scale will continue to increase as we move into warmer weather





## Agriculture / Commercial Horticulture - Mark Seitz

- · Much needed rainfall came to Pender County the last two weeks. Rainfall amounts ranged from 1" to 3" across the county between the two storms.
- · Frost protection measures in strawberries and blueberries were successful. But secondary disease and insect management problems arose with their use. Worked with farmers to address botrytis (plant disease) in strawberries and to assess freeze damage in blueberries and strawberries.
- $\cdot$  Walked winter wheat fields to look for winter freeze damage from the freeze events in early and late March.
- · Collected soil samples for background data at a soil nutrient research project site. With high fertilizer prices farmers are trying to increase their use of poultry manure as a fertilizer source. Extended use can lead to high zinc levels.
- · Highly pathogenic avian influenza (HPAI), carried by wild birds, forced the NC Department of Agriculture to euthanize 32,000 turkeys on a farm in Johnston County. It is NOT present in Pender County at this time, but backyard and commercial poultry producers should watch their birds closely for signs of respiratory problems and contact their local veterinarian, the state veterinarian or the Extension office for assistance if they suspect HPAI in their flocks.
- · Picked up field corn seed for variety testing as part of a nine county testing program.

### **Community Development - Mark Seitz**

- · Planning is underway for two blueberry gleaning events to be held at the Horticulture Crops Research Station in Castle Hayne. Harvested blueberries will be donated to the Eastern NC Food Bank in Wilmington and other food banks in eastern NC.
- · Partnering with the NC Blueberry Festival Planning Committee to secure sponsorship for two charter

buses that will shuttle people from Burgaw to the Horticulture Crops Research Farm in Castle Hayne as part of the NC Blueberry Festival. The goal is to give people attending the blueberry festival in June, a one-hour tour of the research farm and talk to NCSU researchers who are looking for ways to increase the health, nutrition, and productive value of blueberries.
