## Q&A for Central Pender Park RFQ # 23-252

- Page 3 states the County is seeking an engineering firm for the project. Does the County have any objection to a
  landscape architecture firm taking the lead as the prime consultant with a civil engineering firm being included
  on the team as a sub consultant for all engineering-related scope items? The contract will be awarded to a NC
  licensed firm with the resources to complete the scope, which may be primarily a landscape architecture firm.
  If respondents are not licensed engineering firms, please include all requested information regarding the
  qualifications of the NC licensed engineering firm you intend to work with in addition to your own firm's
  qualifications.
- 2. Page 3 states the project is "design/build". This typically means that a general contractor hires the design consulting firms under their single contract. Is this truly a design/build contract or is design under one contract with the County and a second County contract with a general contractor to build it? It does not state design/build it specifically says it is a design-bid-build project.
- 3. Is the initial survey work adequate for engineering drawings or is additional topographic surveying services required? A survey was performed in 2000 (deed book 1604, page 143). Additionally, a wetland delineation was performed in 2021 which shows several jurisdictional ditches, and some other water features that will impact the design. Whether or not additional topographic surveying will be required would be determined by the selected engineering firm.
- 4. Can the County provide a PDF of the initial survey for our team to review? Survey and USACE wetland delineation are attached.
- 5. Will the county accept a pre-engineered and prefabricated restroom-concession building as opposed to designing one from scratch which would require an architect, MEP consultant and structural engineer as part of the proposal team? The county has sealed plans for the restroom/picnic shelter, only a small fee to the design team to adapt the plans for this site specifically will need to be included. A construction cost for the building is also known, but if a prefabricated building is less expensive than our design, and meets the same guidelines, the County would consider the option.
- 6. Will the county accept a pre-engineered picnic shelter (such as through Poligon or Icon)? See answer to # 5.
- 7. For references, you're asking for "Prior experience and performance with Pender County or similar", what does "similar" mean in this context? Are you looking for geographic region similarity, scope of work similarity, or both? As part of the references section, we are interested in knowing if you have performed any work with Pender County or other government agencies.
- 8. We wanted to reach out about the Pender Central Park Expansion listing in Burgaw, NC. Are there any mandatory meetings or required site visits? Also, is there any important documentation needed for this project? There are no mandatory meetings in order to be considered for this RFQ. Documentation provided with this addendum and the original RFQ should suffice. If respondents are not licensed engineering firms, please include all requested information regarding the qualifications of the licensed engineering firm you intend to work with in addition to your own firm's qualifications.
- 9. What permits do you anticipate will be required? In addition to the typical site development permits there may be additional permitting required depending on the ultimate design as it relates to the Clean Water Act.

- 10. What is the extent of assistance needed with the advertising/bidding process? The County will expect assistance in preparing accurate bid packages for the required trades and be prepared to answer and technical questions regarding the bid package. We may opt to administer the bidding process completely or we may request the firm produce the necessary publications as well as administer the bid process in coordination with County staff.
  - a. Will the selected firm be assisting with construction administration (CA) or have complete CA oversight? The County is seeking a firm capable of providing complete construction administration, however we may opt to administrate all of the construction requirements in house.
- 11. Is the project design coordination solely with Pender Co. or are there other entities involved? All project coordination will be directly with County Staff, there are no other entities involved.
- 12. Will a TIA be required? We do not anticipate a requirement for a traffic study at this site.

We apologize that we have had technical difficulties with the County website. However, we are continuing with our original schedule as planned.
