### Addendum 1 has been issued to elaborate on the Purpose, provide the weight of Evaluation Criteria, in addition to extending deadlines for the submission of Questions and SOQs.

### **Evaluation and Selection Process**

The criteria by which the packages are evaluated include, but are not limited to:

- Clarity of Statement of Qualifications (10pts)
- Firm's understanding and approach of project and proposed time line (10pts)
- Firm's knowledge and demonstrated experience specifically with library design, construction, and operations planning (20pts)
- Demonstrated competency/experience of firm and key personnel related to scope of services requested (25pts)
- The firm's demonstrated ability to carry out like projects on time and within budget (10pts)
- References (10pts)
- Interviews if needed (15pts)
